



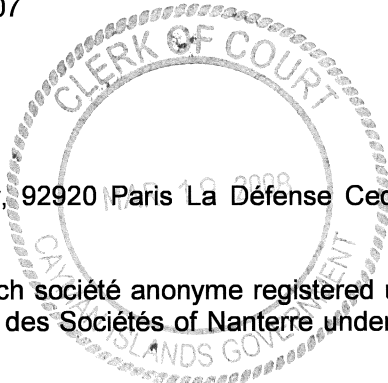

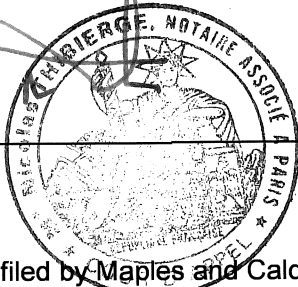
I, Christophe Jallois of 9, quai du Président Paul Doumer, 92920 Paris La Défense Cedex, France, MAKE OATH and say as follows:
