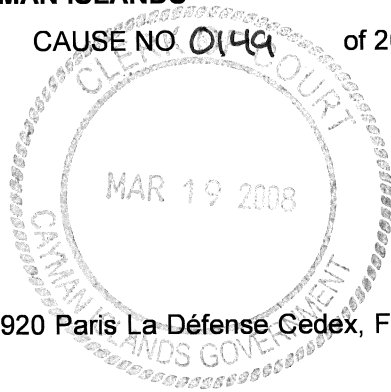

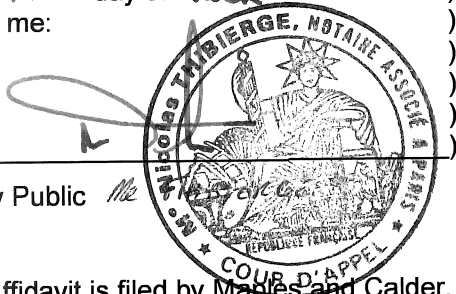
AFFIDAVIT

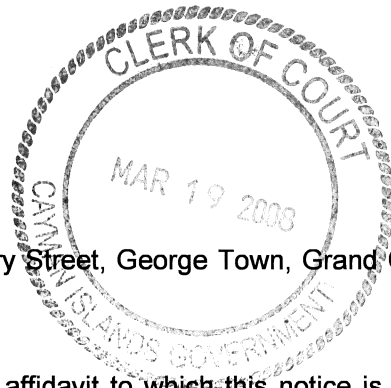


