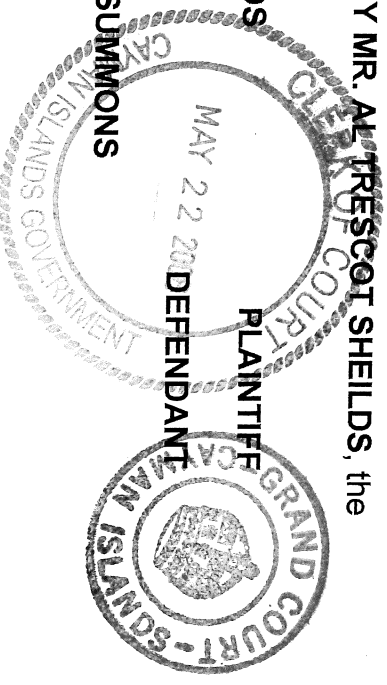

By this Summons, issued on the applicant of AL TRESSCOT SHEILDS of 36
Heather Lane, George Town Grand Cayman, the Plaintiff claim against the
Defendant for guardianship, custody, care and control of their minor child
DILLION PHILIPS under section 7 of the Guardianship and Custody of Children
Law 1996 (revised) AND for the following orders to be made:

1. That the Plaintiff be declared the biological father of the minor child Dillion
Philips born 8th March 2007 and that the Plaintiff be given shared parental
responsibility for the said child.
2. That the Plaintiff be granted guardianship, custody, care and control of the
minor child DILLION PHILIPS.



3. That the Defendant be restrained whether by herself, her servants and /or agents from removing or attempting to remove **DILLION PHILLIPS** from the jurisdiction without the express written consent of the Plaintiff or this Honourable Court.
4. That the Plaintiff be granted defined access to the minor child.
5. Such further or other relief as this Honourable Court deems just.
6. That the Defendant pays the Plaintiff cost incidental to these proceedings.

If the Defendant does acknowledge service, such judgment may be given or order made against or in relation to him as the Court may think just and expedient.

**DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF ORIGINATING SUMMONS**

The accompanying form of acknowledgment of service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person. After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an acknowledgment of service and return it to the Courts Office.
2. If you wish to defend claims made in the originating summons, or intend to attend the proceedings and to participate in them so far as necessary (although not necessarily in an adversarial manner) you should tick the "Yes" box in paragraph 2 of the acknowledgement of service.
3. For the purpose of calculating the period of 14 days for acknowledgment of service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
4. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Originating Summons)".
5. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
6. Where the Defendant is used as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
