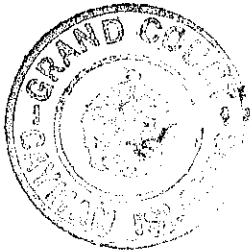

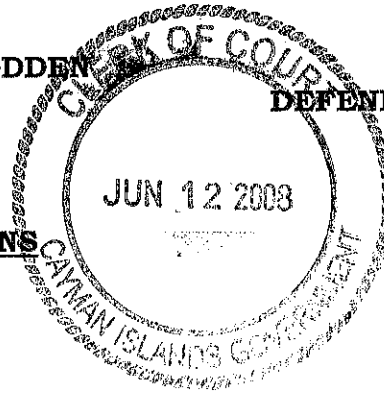

WRIT OF SUMMONS

TO: Dawn & Robert Bodden

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within [14 days] after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service, stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM

1. The Defendant was at all material times the owner of the property situated at No. 30 Moon Bay, a residential development situated in Bodden Town, Grand Cayman and the subject of the Strata Plan #59.
2. The Plaintiff was at all material times the registered Strata Plan #59 governed by the Strata Corporation By-Laws which controls, manages and administers the Common Property of all proprietors within the Moon Bay residential development situated in Pease Bay, Bodden Town, Grand Cayman.
3. Pursuant to Strata Corporation By-Law 36 the Defendants obligation is to make strata payments in respect of their Strata lot within 21 days of such demand being issued.
4. In accordance with the Strata By-Laws the Plaintiff has provided written notifications of Strata payments due by way of monthly statements to the Defendant.
5. The Defendant has failed to honour their payments and is now in arrears in the amount of CI\$20,314.81.
6. In addition to the amount owed as set out above, the Plaintiff is entitled to interest from the date of the "By- Laws" agreement, the rate of interest being that established in By-Law 36 (iii) payable at the rate of 2% per annum above prime rate of the USA at the time of default in the event of non-payment of strata fees.
7. Such interest has been charged to the Defendants in their monthly statements to date of issue of Writ.

STATEMENT REGARDING INTEREST

1.

a)The Plaintiff seeks pre and post judgment interest from the date of issue of proceedings in accordance with the Judicature Law (2007 Revision) and the Judgment Debt (Rates of Interest) Rules as amended from time to time.

b)The interest rate as per the Judicature Law (2007 Revision) is 7.25% per annum

c)The amount of interest accruing each day following the issue of this Plaintiff is CI\$4.04

AND THE PLAINTIFF claims:

1. Damages
2. Interest in accordance with the Judicature Law (2007 Revision)
3. Costs
4. Such further and other relief as this Court may deem just

If, within the time for returning the Acknowledgement of Service, the Defendant pays the total amount claimed of CI\$21,117.81 (including fixed costs of CI\$500 filing fees of CI\$200 and ad valorem filing fees of CI\$103) further proceedings will be stayed. The money must be paid to the Plaintiff or his Attorney.
