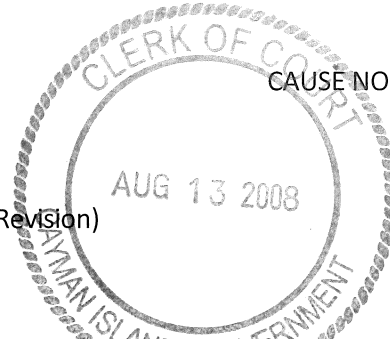


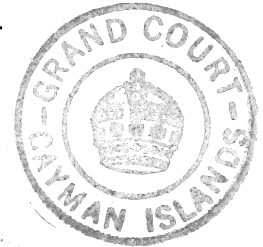

AND UPON being satisfied that the cause or matter is a financial services proceeding

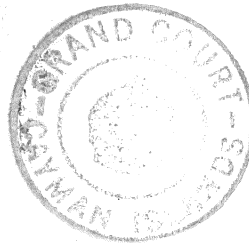
IT IS ORDERED that –
