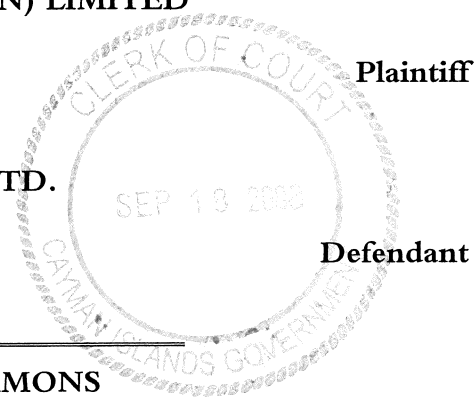

 - Transfer and Variation registered on 27 December 2002;


made between the Defendant and the Plaintiff, Butterfield Bank (Cayman) Limited (formerly Bank of Butterfield International (Cayman) Ltd.) (the "**Charge**"), by virtue of which the properties in the Registration Section **West Bay North West, Block 3D, Parcels 157H24, 157H28, 157H31, 157H34 and 157H37** (the "**Properties**") were charged by the Defendant by way of legal charge in

favour of the Plaintiff to secure the principal sum of US\$1,800,000 and interest at the rate specified in the schedules thereto.

2. That the Defendant deliver possession of the Properties to the Plaintiff.
3. That the Charge be enforced by the sale by private treaty of the Properties (as well as by Public Auction).
4. That the terms and conditions of sale by private treaty be determined, if any.
5. That leave be granted to issue a Writ of Possession with respect to the Properties.
6. Such further or other relief as the Court thinks fit.
7. Costs.

AND LET THE DEFENDANT within 14 days after service of this summons on it counting the day of service, return the accompanying Acknowledgement of Service to the Courts office.

 2. If the Defendant does not attend personally or by their attorney at the time and place above-mentioned such order will be made as the Court may think just and expedient.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE OF ORIGINATING SUMMONS

The accompanying form of Acknowledgement of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person. After completion it must be delivered or sent by post to the Law Courts, PO Box 495, Grand Cayman, KY1-1106, Cayman Islands.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. If you wish to defend claims made in the originating summons, or intend to attend the proceedings and to participate in them so far as necessary (although not necessarily in an adversarial manner) you should tick the "Yes" box in paragraph 2 of the acknowledgment of service.
3. For the purpose of calculating the period of 14 days for acknowledging service, an Originating Summons served on the Defendant personally is treated as having been served on the day it was delivered to him.
4. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Originating Summons)".
5. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
6. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
7. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
