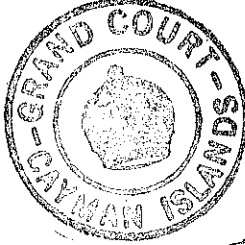

**THIS WRIT OF SUMMONS** has been issued against you by the above-named Plaintiff in respect of a claim set out the next page.

**Within** fourteen (14) days after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O.Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

Issued the 24th July, 1995.

**NOTE:** This Writ may not be served later than 4 calendar months (or, is leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

**INDORSEMENT**



1. The plaintiff is the owner of Stanwyck Plaza in George Town
2. The defendant operates a business in Elizabethian Square.
3. On the 14th day of September, 1992 the defendant entered into a written rental agreement with the plaintiff to rent No. 4 shop in Stanwyck Plaza at a monthly rent of \$880.00 payable in advance on the 1st day of October, 1992.
4. The defendant failed to pay the rent from January to July, 1994 and despite several verbal and written demands the defendant moved out on or about the 7th August, 1994 without paying the amount due.

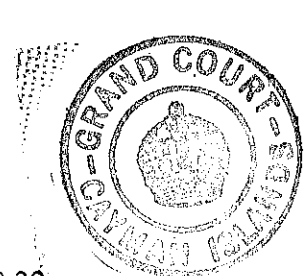
**WHEREFORE THE PLAINTIFF CLAIMS:**

1. Rent due from the 1st January, 1994 to the 6th August, 1994 = \$6,330.32
2. Interest at the rate of 8 3/8% per annum from the date of judgement until payment
4. Costs to be taxed.

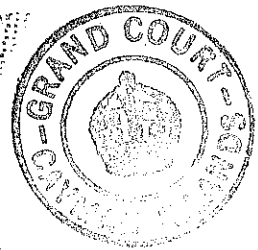
