



AFFIDAVIT

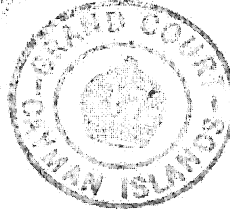

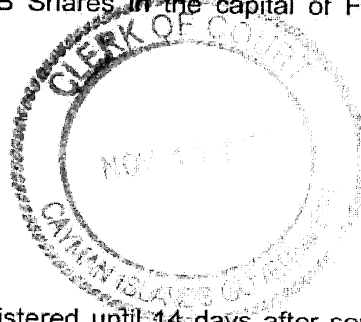
