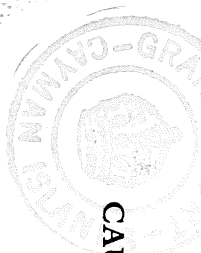
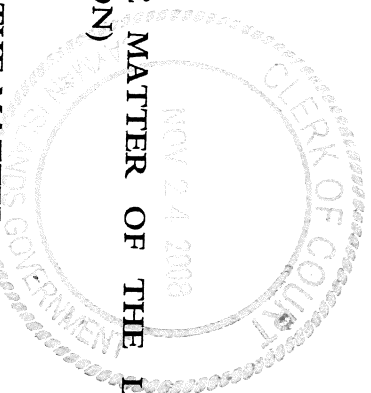

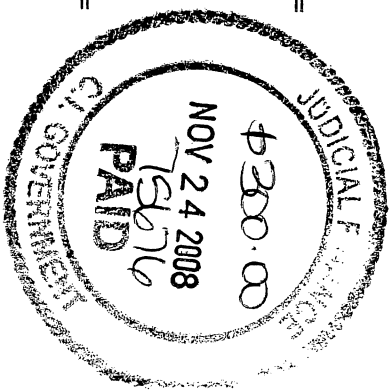

LEGAL PRACTITIONERS (STUDENTS) REGULATIONS

(2008 Revision)

Application to be admitted as an attorney-at-law

(Section 3(1)(c) and Regulation 15(2))

We, Bruce Putterill of PO Box 190GT, George Town, Grand Cayman and Deborah Alliyah McCarthy of PO Box 190GT, George Town, Grand Cayman do solemnly and sincerely declare as follows:

A. And I the said Deborah Alliyah McCarthy for myself do say that:

- (1) I am the one and the same person named as the Articled Clerk in the Articles of Clerkship dated the 1st day of September 2007 and a true copy of same is now produced and shown to me marked with the letter "A" (the "Articles").
- (2) The said Articles were registered pursuant to the Legal Practitioners (Students) Regulations (Revised) (the "**Regulations**"), namely Regulation 17, on the 31st day of August 2008.
- (3) Since the date of execution of the Articles, I have been actually employed in the proper business practice and employment of Appleby, Attorneys-at-Law and have not held any other office or engaged in any other employment during that period.
- (4) I have never been convicted of a criminal offence.
- (5) I was awarded the Attorney-at-Law Certificate by the Legal Advisory Council on the th day of November 2008 and a true copy of same is now produced and shown to me marked with the letter "B".
- (6) I am a Caymanian by marriage in accordance with Section 20 of the Caymanian Protection Law, 1984 as exhibited in my Application to Register Articles dated 1st September 2007 and a true copy of same is now produced and shown to me marked with the letter "C".


B. And I the said Bruce Putterill for myself do say that:

- (1) I am a practising attorney-at-law qualified under section 16(1) of the Legal Practitioners Law (2007 Revision) to take a person into my service as an articled clerk, and am the same person named as Principal in the Articles, now produced and shown to me marked with the letter "A".
- (2) The said Deborah Alliyah McCarthy has been bound by the Articles to me since the 1st day of September 2007 and has since that date been actually

employed in my proper business practice and employment as an Articled Clerk.

- (3) The period of articles which has been served satisfies the requirement of Regulation 17 (1) (c) of the Regulations.

And we make this solemn declaration conscientiously believing the same to be true and by virtue of the Voluntary Declarations Law (1998 Revision).


