

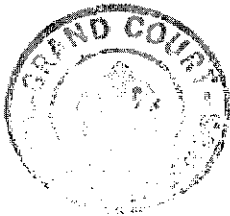

EX PARTE ORIGINATING SUMMONS

LET ALL PARTIES concerned attend before the Judge in Chambers at the Law Courts, George Town, Grand Cayman on the day of 2009 at o'clock in the forenoon upon an application by the Attorney General for the following orders that:

Box 219GT, Fifth Floor, Strathvale House, Grand Cayman, Cayman Islands in their capacity as Liquidators of BII Creditanstalt International Ltd. do appear at such place, date and time as the Clerk of Courts shall appoint to be examined upon oath by the said Clerk of Courts in terms of Schedule A attached hereto.

2. Lawrence Edwards and David Walker of PriceWaterhouseCoopers, P.O. Box 219GI, Fifth Floor, Strathvale House, Grand Cayman, Cayman Islands in their capacity as Liquidators of BII Creditanstalt International Ltd.do appear at such place, date and time as the Clerk of Courts shall appoint and there produce to the Clerk of Courts the documents set out in Schedule B attached hereto.
3. That the said Lawrence Edwards and David Walker do apply to the Grand Court pursuant to section 4 of the Confidential Relationships (Preservation) Law for directions as to the manner of producing the documents within 7 days of the service of any order of this Honourable Court therein.
4. That the Clerk of Courts do cause all evidence and documents produced by the said Lawrence Edwards and David Walker to be filed in the Registry of the Grand Court and do forward the said evidence and documents to the First Instance, Second Term Court of Carmelo, Republic of Uruguay.
5. Such other orders and directions as this Honourable Court deems fit.
