

The Chief Immigration Officer unreasonably refused to grant extension for a period of up to six(6) month to the dependent children Bessy Tatiana Rodriquez Zuniga and Maynor Rogelio Rodriquez Zuniga pending an Appeal to the Immigration Appeal Tribunal from the Caymanian Status and Permanent Residency Board not to include them on the Permanent Residency and Employment Right Certificate for the Second Plaintiff, the Spouse of a Caymanian, namely the Plaintiff Adriana San Zuniga Levy the Spouse of the Plaintiff Harry Morales Levy.
