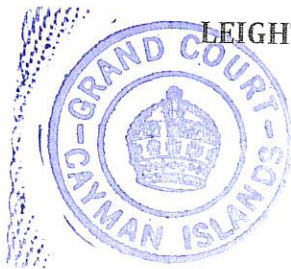

ORIGINATING SUMMONS

LET THE DEFENDANT of George Town, Grand Cayman attend before the Judge in Chambers, at the Law Courts, George Town, Grand Cayman on the 17<sup>th</sup> Day of May 2009 at 9:30 o'clock on the hearing of an application by the Plaintiff that:-

- (a) That the Defendant make payments towards outstanding bills to the George Town Hospital for the costs related to prenatal care, delivery and birth of the child that were not covered by the Plaintiff's insurance and other expenses related to the child;
- (b) That the Defendant pay reasonable maintenance of the said child;
- (c) For an attachment of earnings order.
- (d) That there be such further Orders as the Court deems just and equitable in the circumstances;
- (e) Costs;

AND LET THE DEFENDANT within 14 days after service of this summons on him counting the day of service, return the accompanying Acknowledgement of Service to the Courts office.
