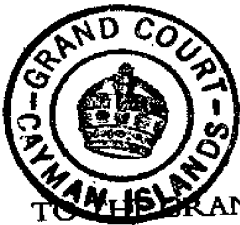


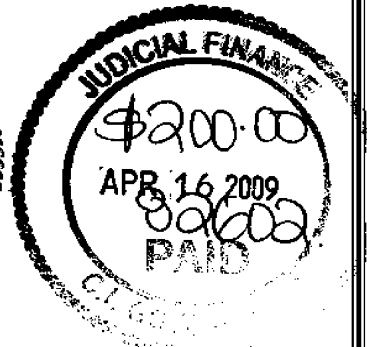

PETITION



TO THE GRAND COURT OF THE CAYMAN ISLANDS

The Humble Petition of Santa Clara II Fund (In Voluntary Liquidation) c/o Kinetic Partners (Cayman) Limited of Harbour Centre, 1st Floor, PO Box 10387, Grand Cayman, KY1-1004, Cayman Islands shows that:

1. Santa Clara II Fund (the "Company") is an exempted limited liability company registered by way of continuation in the Cayman Islands under the Companies Law of the Cayman Islands.
2. The registered office of the Company is Kinetic Partners (Cayman) Limited of Harbour Centre, 1st Floor, PO Box 10387, Grand Cayman, KY1-1004, Cayman Islands.
3. By special resolution of Aspen International Investment Limited, the sole shareholder of the Company, made on 23 March 2009, the Company was placed into Voluntary Liquidation and Nicolas Matthews and Mark Longbottom of Kinetic Partners (Cayman) Limited of Harbour Centre, 1st Floor, PO Box 10387, Grand Cayman, KY1-1004, Cayman Islands were appointed as Joint Voluntary Liquidators of the Company.
4. Dawn Davies and Anthony Inder Rieden of Charlotte House, Charlotte Street, Nassau, P.O. Box N9205, Nassau, N.P. The Bahamas, were the Directors of the Company on the date of the commencement of the Voluntary Liquidation.


5. The Directors of the Company have indicated to the Joint Voluntary Liquidators that they do not intend to swear a declaration of solvency in respect of the Company pursuant to s124 of the Companies (Amendment) Law, 2007, on the ground that the Company is at best of doubtful solvency.
6. The Joint Voluntary Liquidators of the Company are qualified insolvency practitioners and consent to being appointed as Joint Official Liquidators of the Company.

YOUR PETITIONER THEREFORE HUMBLY PRAYS THAT:

1. Santa Clara II Fund's Voluntary Liquidation be continued, subject to supervision by this Honourable Court pursuant to section 124 of the Companies (Amendment) Law, 2007.
2. Such other orders be made as the Court shall deem fit.
